

## SCCC Board meeting Tuesday July 5<sup>th</sup> 2022

**Present:** Veda, Alice & Loraine. Mary Jo Bennett (new board member) staying away for safety reasons as a family member was exposed to Covid. Linda has an ill grandson. Did not hear from Coty or Dave.

Moment of Silence; there were only 3 board members present, so no quorum, and a more informal approach with a visitor.

**Guests:** Hazel Wiggins, previously invited by Veda. Hazel would like to get more involved in the community and comes from a family with strong ties and many years here. Hazel has teenage sons and would like to know what SCCC will offer going forward. Alice explained that Phase 3 will have touch down space for business people, online businesses, medical appointment private office space for an online and private appointment. We asked her what she thinks is needed for younger people.

**Grants:** Alice will meet on Friday to talk with county officials about how to spend the money for Phase 3. Architect drawings, plan on biddings, builders etc. County has the money and we may need 3 bids. Will take the lowest bid. Alice has multiple questions and will have first meeting Friday July 8<sup>th</sup>. Build in 2 years.

**Walking trails:** Searching for grants to develop a trail to encompass the entire campus. Stretching around the perimeter of SCCC & SCVFD, the Nutrition Center and the Collection site. We would like to see a new children's playground and benches around the trail. The goal being to allow people to have a safe place to walk, that is off the road. Exercise, fitness and rehabilitation for those recovering from an illness etc. Alice has asked Loraine to lead this effort. She can build a team to support.

**Building Maintenance;** Roof- Alice and Shawn met Norris Gentry & county people. The roof needs to be repaired and ideally the county would pay for it. The Golden leaf Foundation money would not be used to repair Ph1 or Ph2. SCCC has raised over \$900,000.00 for the building over the years. Can they help us with the roof since they own the building?

**Utility room:** No electricity, leaks in roof caused that. Have electrician repair.

**Sheriff's office** – With FBEMC bringing high speed internet, maybe we can open up this space for public use when the building is open?
